Executive Summary of the Evaluation Report

Alpha Namibia Industries Renewable Power Limited (ANIREP) & The Frans Indongo Investment Trust (FIIT) Joint Venture	No	 The Board resolution from one of the JV partners (ANIREP) authorizing the Special Power of Attorney was not included in the submission. The ESHS Methodology submitted in BF2-1 was found non-responsive as it only contained a Fire Fighting System from CATL, and a System Manual related to the Medium Voltage Power Station from SMA. The Bidder entirely missed the subject of the ESHS methodology requested in the Bidding Document, Section IV, Bidding Forms, BF2-1. The Bidder has not provided Letters of Intent from its suppliers for the key equipment without modifications of the required content. Although a letter of intent of the Battery Cell from CATL was provided, the letter of intent was provided to SMA Altenso (Specialized subcontractor) and not to the Bidder. The Bidder made substantial modification to Bidding Form BF2-3.2: Key Equipment Letter of Intent, by deleting the following wording(s):

		a. "The annual cost for the equipment service contract covering the scope described in the Employer's Requirements will not exceed [insert annual maximum price for service contract] EUR per year for at least 10
		b. "If the battery system is in the scope of the subcontractor/supplier: We declare that a take back of the battery system according to section the Employer's Requirements is included in the supply at no extra cost."
		In line with ITB 13.1, the Employer concluded the modification to the Letter of Intent to be non-responsive / unacceptable.
		 5. In Bidding Form, BF2-6, the Bidder has not confirmed nor proposed a technical deviation in BF2-4 to the Load Factor max. over 24h, Availability Warranties, Warranted Efficiency at Load Factor >= 5%, Warranted Efficiency at Load Factor >= 2.5% and Warranted Efficiency at Load Factor >= 1.5%. 6. The Bidder provided a Product Warranty of the Battery System of 3 years, which is less than the 10 years required, however no technical deviation was proposed in BF2-4. 7. The Bidder did not provide CVs and/or supporting documents for several key personnel.

The Bidders proposal of calculating the performance damages cannot be accepted as it affects the price, scope and quality of the Works. In addition, this deviation may limit the Employer's rights or Bidder's obligations under the Contract. Furthermore, the Bidder was given an opportunity in the First Stage Bid to propose any deviation to the Bidding Documents for the Employer's consideration and discussion during the Clarification Meeting. As such, the Bidder does not materially conform with its First Stage Bid. 2. The Bidder included material legal and commercial deviations that were not withdrawn even after Post Bid clarifications: a. The Bidder deviated from the minimum Product Warranty requirements and confirmed that the cost for the Product Warranty only includes the 2 years after completion. This deviation cannot be accepted as it affects the price, scope and quality of the Works. In addition, this deviation may limit the Employer's rights or Bidder's obligations under the Contract. Furthermore, the Bidder was given an opportunity in the First Stage Bid to propose any deviation to the Bidding Documents for the Employer's consideration and discussion during the Clarification Meeting. As such, the Bidder does not materially conform with its First Stage Bid. b. The Bidder included a deviation in which the Bidder reserves the right to negotiate and modify the terms of the

contract, such as those regarding
milestone payment terms, performance
damage, etc. This deviation cannot be
accepted as it affects the price, scope and
quality of the Works. In addition, this
deviation may limit the Employer's
rights or Bidder's obligations under the
Contract. As such, this deviation is
considered a material deviation.
Furthermore, the Bidder was given an
opportunity in the First Stage Bid to
propose any deviation to the Bidding
Documents for the Employer's
consideration, discussion during the
Clarification Meeting as well as provide
specific deviations with the Second
Stage Bid. As such, the Bidder does not
materially conform with its First Stage
Bid.
3. Upon reviewing the Bidder's soft copy
submission, the BEC discovered that it
contained the Financial Part of the Bid,
which should have been in the Financial
Part envelope in accordance with ITB
35.1. As such, the Bidder's Bid was
declared non-responsive in line with ITB
29.5 which reads:
"The Technical Part shall not include any
financial information related to the Bid price.
Where material financial information related
to the Bid price is contained in the Technical
Part, the Bid shall be declared non-
responsive. "

12. Best Evaluated Bid:

In line with ITB 56.1, the Best Evaluated Bid (i.e., the highest scoring Bid) in the combined Technical and Financial evaluation is **Shandong Electrical, Engineering & Equipment Group Co., Ltd (SDEE) and Zhejiang Narada Power Source Co., Ltd Joint Venture**, for the amount of EUR 20 million (Excluding VAT).
