NAMPOWER ANNOUNCES THE KUDU EPC PRE-QUALIFIED CONTRACTORS

The NamPower Board of Directors approved the shortlist of fifteen (15) international companies and consortia to participate in the Engineering, Procurement and Construct (EPC) tender for the design, supply, manufacture, delivery, erection, test and commissioning of the 800 MW Combined Cycle Gas Turbine (CCGT) Kudu Power Station to be built near Oranjemund in the south-western part of Namibia. The pre-qualification bid for the EPC closed on 17 June 2013.

NamPower received forty-five (45) bids for the Pre-Qualification tender. The following fifteen companies/consortia complied with the qualification criteria and advanced to the full EPC tender:
