## Why do you need to complete this form?

Under the market rules, in exception of NamPower, you are not permitted to participate in the MSB electricity

Under the market rules, in exception of NamPower, you are not permitted to participate in the MSB electricity markets or to cause or permit any physical service to be conveyed into, through or out of the transmission system unless you have been registered by the MSBM office as a market participant, and your facility to or from which the physical service is to be so conveyed has been registered by the MSBM office, in accordance with the market rules.

The MSBM office is licensed by the Electricity Control Board (the "Regulator") to operate the electricity market in Namibia. One of the MSBM Office responsibilities is to manage the registration of market participants in the electricity market. You must complete and submit this form to apply to be registered as a market participant if you wish to participate in the electricity market and/or convey any physical services into, through or out of the transmission system.

## Why did MBAO develop this form?

The MSBMO has developed this form for applicants to apply for registration as market participants (Eligible Seller or Contestable Customer) as described in the market rules.

#### What if MSBMO needs further information and clarification?

The MSBMO shall request for a meeting or in writing any further information or clarification required to process your application. It is important that you respond promptly to the MSBMO's requests in writing. If the MSBMO does not receive the requested information or clarification to its satisfaction within 15 business days from the date of its request (unless the MSBMO agrees with you to a longer period), then your application shall be deemed to have been withdrawn and you shall be required to submit a new application if you still wish to apply for registration as a market participant. All communications between you and the MSBMO in respect of such further information or clarification shall be in writing.

#### When will you know the outcome of your application?

The MSBMO will notify you in writing of the outcome within 20 business days of the receipt of

- (i) this form; or
- (ii) all further information and clarification requested by the MSBMO,

If your application is denied, the notification will identify why this was the case. If the MSBMO is satisfied that you may be conditionally registered as a market participant under the market rules, the MSBMO will also notify you of the same.

#### Is there an application fee for your application to register as a market participant?

There is currently no market participant registration application fee for each application to register as a market participant. In future, please refer to the NamPower website for prevailing registration application fee if any.
